- 8. <u>Board Auditor</u> Yearly Retainer of \$8,000.00 to include usual auditing and audit report as well as assistance in preparing the annual budget. Any additional services to be billed on an hourly basis, pursuant to further Resolution of the Board and reimbursement of expense.
- 9. Board Accountant \$20,000 per year
- 10. <u>Civilian Dispatcher</u> Hourly rates on a shifting scale depending on experience and duties. This position and all appointments thereto and the compensation have been established by prior Resolutions of the Board which are separately renewed and extended on a yearly basis with the last renewal effective through April 30, 2020, so that an additional Resolution will be separately passed to provide for a continuation of these positions, continuation and/or new appointment to these positions and continuation and/or change in the rate of compensation.
- 11. <u>Clerk</u> (2 positions) For the first position, \$5,654.00 for the year. For the second or newer position, \$37,910.00 for the year.

**BE IT FURTHER RESOLVED** that the job description for this paid position as Civilian Dispatcher continues to be classified as Public Safety Telecommunicator Trainee to meet the civil service job specification number 06629 under the Department of Personnel in the State of New Jersey for this position and/or Public Safety Telecommunicator for those who have successfully completed 12 months of service all of which are considered as under civil service, but, non-competitive positions with the understanding that these positions are subject to civil service requirements and interpretations as provided from the initial Resolution by this Board dated April 25, 1994, creating this position.
